Christian Religion and the Task of Nation Building

Abstract

It is therefore my intention in this article, to highlight the areas where the church once played a very remarkable and important role in sustaining the society, where it has derailed and also let the different religious leaders know what the society expects of them in the task of nation building. This nation is not to be left at the mercy of the government and the government alone. It is hereby recommended, that both non governmental and faith based organizations should put their hands on the desk to see our nation resuscitated. It is often said that religion is the conscience of the society and so it should give a direction to the said society. We shall also frown at the rate at which some church denominations now sit on the fence, when it has to do with the affairs of the nation. When the church ventures into social actions like the provision of quality education, social amenities and other developmental strategies, the society which is at the receiving end gets better. Morality which is the watchword of the different religious organizations, especially the Christian religion, is expected to be inculcated into the society. This paper finally concludes that the churches which spring up almost everyday should not only think of heaven and heaven alone, but that they should be

earthly useful, for without religion in the society, there will be chaos and anarchy in the society.

Introduction

The Christian religion is world affirming and not world denying, it is a religion that is relevant both in this world and in the world to come. The world today is decaying greatly as a result of utter neglect and lack of commitment to it. It is seen to be the sole responsibility of the government to care for the society and the inhabitants. By playing a lead and remarkable role in nation building, the church would have succeeded in exhibiting her social action, in this world of ethnic wars, social insecurity, political underdevelopment, prostitution, drug abuse environmental degradation and the like. A good Christian like the prophets of old, should see himself or herself as a social engineer who should assume the duty constructing and reconstructing the society. We should be more proactive in issues that affect the nation and the society in general, not the kind of quietist of Christians that we have today.

It is my intention therefore in this article, to present a skeletal solution to this ravenous social neglect on the side of the Christian religionist or adherents of today. I will attempt awakening the consciousness of this problem in the mind of those who read this paper making reference to how the Christians in the past were instrumental to social development. I shall also suggest some possible solutions to the problem so created by Christians

The Church as a Social Remedy

It is indeed a pity that today, most of the churches are business minded and no longer think of what to do for the society, but what the society will do for them.

According to Obuba (1996:84)

When the missionaries came to Nigeria, their method of evangelism was that Laid down by our lord Jesus Christ. They took care of the social, spiritual, physical and intellectual needs of people. Each of these denominations established churches, schools, farms, clinics and hospitals to cater for these needs. It was usual to see a small church standing between rows of classroom blocks, a dispensary in one of the classrooms and a garden at the back of the building.

Stott (1992:222) on his own asserted that, "unless we listen attentively to the voices of secular society, struggle to understand them, and feel with people in their frustration anger, bewilderment and despair, weeping with those who weep, we will lack authenticity as the disciples of Jesus of Nazareth.

According to Onwu (1996:11) the church is not living up to her expectation in the society, in the provision of the basic needs of the people. He said that,

The church in Nigeria has not participated fully in the use of power to create peace, provide basic needs of her people promote human rights, and check the rise of secular power of dictatorial government.

The Church and Education

In Nigeria as a nation, there could not have been education as we have it, apart from the efforts of the missionaries, who came to Nigeria both with western education and the Christian religion. While the Muslim missionaries rejected anything western or European as we call it, the Christian missionaries were accepted down have in the southern part of the country

Onwubiko (985:214) noted that:

Evangelical work and long monopoly of education played a crucial role in the rise of nationalism and the consequent emergence of the modern states of West Africa. By their promotion of education, they helped to produce the western African elites who became the leaders of modern West African nationalism.... Without the missionary enterprise both the timing and nature of the awakening of social and national consciousness would have been different. The introduction of Christianity is the factor in building West African states.

The Church and Development

The Bible which is the holy book of the Christians does not in any way the sustenance and maintenance of the nation, right from the beginning universe, according to the creation story. God had social developm mind, He said to the first man and the first woman, that they should go a Be fruitful and multiply and fill the earth and subdue it, and have don over the fish of the sea and over he birds of the air and over every living thing that moves upon the earth. (Gen. 1:28) RSV

The word dominion here means to control and to direct and to rule and also look after. It means that the world was handed over to man to take care of. This implies that the wellbeing of man or the human being was and is still the will of God, having known that neither the fish of the sea, nor the birds of neither the air, nor any other created thing on earth can take care of the universe, without confusion and even the damnation of the handwork of God, the universe. Man is trusted among all the living things by God as the one who can build the earth to His taste.

Almost every church now emphasizes tithing and sowing of the seed of faith. The prosperity preachers are now on the increase, whose language is that of money, money and money they will readily pronounce that their God is not a poor God. The masses are grossly being deceived and mislead. a times one wonder whether there is any difference between these sole proprietor churches and the money doublers, who ask you for money that they may double it for you. The real thing would have been that if anybody knows how to double money, he should not ask anybody to pay him for doubling money, since he or she would have doubled more than enough for himself and even the people around him.

These new generational churches are in the habit of promising Heavens on earth, some of them promise you academic breakthrough, when they cannot make any comprehensive statement or speak good English. They ask you to sow the seed of faith and have as many children as you want, especially when you have an infertility problem, but they themselves go on adopting children due to one infertility problem or another.

One annoying part of this money consciousness on the side of the churches today is that these monies when accrued are not utilized to benefit the society, not even the people that contribute them, instead they build empires universities and other economic institutions, which will only be for the pastors and their families only. They will gain more patronage and more

membership if and only if their money quests are society driven, if the spend some amount on the development of the society, such as build roads and maintaining the old ones, provision of scholarship to some indigent members of the society. But we will devote ourselves to prayer and to the ministry of the word.

Down the memory lane, the church has been of immense help to the less privileged in the society, they took good care of the widows and the orphans. What the early Christians did portrays a kind of division of labour, between those who would serve the word of God for the spiritual wellbeing and those whose responsibility it was to manage the food, for the physical need of the people.

Man by nature is a psychosomatic being, he is spirit, soul and body, this is why the church of today should be redirected, and a new orientation given to them. They are now more or less preoccupied with soul and soul, heaven and heaven only do they preach. Little attention is being given to the physical needs of the people. The early Christians were both heavenly conscious and earthly minded, what we have today is a band of people who have been made to be so heavenly minded that they have become earthly useless. The primary ministry of the church is to make disciples of all nations, these disciples are not in heaven already, they are called saints militant and not triumphant, and they should by any means be encouraged in their doggedness to succeed. The society should not be seen as a dilapidating house that needed no attention since ours is a world affirming religion.

Youth Unemployment in Nigeria, Christianity a Solution

According to (Bennell,2000, Mkandwire,1996; Momoh,1998), In this sociopolitical context of declining growth and economic reform and restructuring, youth unemployment situation in Nigeria has become critical because it has made labour absorption problematic.

In spite of government pronouncements, several analysts argue that the state's attempt to address the problem of youth unemployment has largely been guided by a vision that neither addresses the livelihoods needs nor meets the real expectations of young people This is to say that the government has not squarely addressed the issue of unemployment and its ravaging problems on the teaming young people in the country. It could at most be said that the government is only paying a lip service to the problems of unemployment. The political status of the nation to a very large extent, depends on their economic status. The church plays and should play more remarkable roles in the economempowerment of the youths for any meaningful development to take p. This is due to the fact that when they are not gainfully employed, they ten channel their strength, resourcefulness, industry and creative ingentowards some activities that will be negative and inimical to the progret the society, such as cultism, rape, burglary armed robbery to mention be few. The youths need a sense of belonging in the affairs of the nation; need to showcase their intellectual and moral development in governate But these are always hampered by unemployment.

The term unemployment is caused by a number of factors are which are, increase in labour supply over and above its demand. The factor is the population growth of the country, and over emphasis oil reveand peoples deemphasize on agriculture and entrepreneurial undertaking is also an issue that where there are jobs, the job seekers are not employer as they do not possess the needed skills for these employments. For McG and Kings (1995) and Hollister and Gold Stein (1994) "The skill that seekers possess do not match the needed demand of employers in Niger This is as a result of the emphasis on paper qualification in Nigeria over above skills and technical know how.

A very large number of the Nigeria youths, most of whom graduates, are now roaming the streets looking for jobs that do not exist. T are getting frustrated, depressed day by day, while some are becoming res and criminals, who are now safe havens for the politicians who want the On the effect of youth unemployment on the nation, (Adebayo;19 Egbuna;2001) opined that, "They now constitute a depleting agent; a he economic burden and liability instead of a resource because they are constructively engaged in productive labour".

Since religion commands respect on opinion in the society, it is a important in the churches missions that they get involved actively in so concern and social change. The church should show a form of solidarity the side of the unemployed and contribute her quota in getting the employed economically, for by so doing, the church will be curbing reducing the social ills and delinquent behaviours that take place as a re of unemployment. It is also expected that the church should play an advocrole against the youth exploitation and neglect by the powers that be in nation, for by so doing, nation building is enhanced.

Christianity and Osu Caste System

In Igbo land, one is referred to as an 'osu' or 'ohu' which in English mean slave, when he, either by choice or coercion is dedicated to an idol or a g

The people, who willingly ran to dedicate themselves to these idols, did that to be safe from the menace and oppression of the society. It was in the era of human sacrifice and trading on human beings. But those who wanted to live made themselves human sacrifices to the gods of the land, which scared away the human oppressors, who became afraid of the gods that now possess these 'osus'. The 'osus' were brought to the gods, according to the religion on ground then, but instead of killing them as burnt sacrifices, their bodies were cut and blood sprinkled on the shrine of the god. Then the life of the people are spared as they become living sacrifices (osu). This social/religious status is transferred to their offsprings and even unborn generations to come. The other people who were not dedicated to the gods began to see them as outcasts, and as properties to the deity. They are easily detected by the names they bear, such as 'nwa osu', 'ohuocha', 'osuagwu', 'osuafor', 'osueke''osuegbu', to mention but a few.

In Igboland, those who are not among the class of the 'osu' people are referred to as 'Nwadiala', 'Nwaafor', or 'Amadi' as the case may be. They are the free born, who are not allowed to intermarry with the 'osu' people. The discrimination became tensed that the 'osu' people were not allowed to take traditional tittles , when the white missionaries came, it were these 'osu' people that were sent to school as a litmus test of what the white men will do to them.

The story is different today. The society has become an egalitarian one, the 'osu' people now take titles, assume political offices, intermarry with the freeborn in some places. This is the work of the church, which preached unity and inclusion in the society. The issue of discrimination and segregation is minimized or even reduced to the barest minimum. Among the Christians today, every body is seen and addressed as a brother or a sister in Christ. Marriage among the Christians today is by the will of God or through the revelation of God; social status has little or no role to play here. In the church today, like in the Anglican Church, we all use one cup for the Holy Communion, non is sent out because he is an 'osu'. It is said that, 'we are one body because we take part in one body' that is the Holy Communion. According to (Stott 1996), church is a wonderfully inclusive fellowship, in which there is neither Jew nor Greek, there is neither slave nor free, there is neither male nor female. In other words, in Christ we have equality.

Worthy of note is the fact that African slave trade which was a flourishing business for the Europeans and the Americans was stopped by a Christian missionary called William Wilberforce. We also know that one of the major founders of Christianity in Nigeria is an ex-slave boy by name Samuel Ajayi Crowther, who later became a bishop.

The Church and Social Concern

In the church, the people are taken good care of, their developmed empowerment is the order of the day, before the advent of Christian women did not have any say in the society.
